## **GOAD SERVICES SPECIAL TERMS AND CONDITIONS**

## 1. Copyright

- 1.1. The Client acknowledges that Copyright in the Goad Plans and Goad Digital Plans (forming part of the Experian Materials) is jointly held with:
  - 1.1.1. O.S. Great Britain (for Plans in England, Wales and Scotland) of Explorer House, Adanac Drive, Southampton, SO16 0AS;
  - 1.1.2. Land & Property Services (OSNI) (for Plans in Northern Ireland) of Lanyon Plaza, 7 Lanyon Place, Town Parks, Belfast, BT1 3LP;
  - 1.1.3. O.S. Ireland (for Plans in the Republic of Ireland) of Phoenix Park, Dublin 8;
  - 1.1.4. (Plans for Jersey & Guernsey) Digimap Limited, Old Guernsey Tobacco Factory, La Remee, St Peters Port, Guernsey, GY1 2ET;
  - 1.1.5. (Isle of Man) Mapping & Charting Officer, Department of Local Government & the Environment, Murray House, Douglas, Isle of Man, IM1 2SF.
- 1.2. Accordingly, during the continuance of this Agreement, the Client may make or prepare hard copies of the Experian Materials subject to the following conditions:
  - 1.2.1. The Client shall be permitted to make unlimited copies of extracts from the Goad Digital Plans as long as the extracts are no greater then A4 (210 mm x 297 mm) size, as determined at the scale of the original plan(s).
  - 1.2.2. The Client shall also be permitted to make limited numbers of copies of A3 to A0 extracts from the Goad Digital Plans, as determined at the scale of the original plan. A3 to A0 copies should be for the Client's own internal business use and not for external advertising or marketing purposes.
  - 1.2.3. The Client may not, without prior written permission of Experian, make copies of extracts from Goad Digital Plans at any other size or scale, except when reproduction is officially called for in connection with any proceedings on parliamentary, judicial, royal commission or statutory enquiry matters on which the Client is a litigant or is directly acting on behalf of such litigants.
  - 1.2.4. No copies will be made by the Client of any of the Goad Digital Plans unless purchased by the Client direct from Experian.
  - 1.2.5. The Client will not sell, licence, lend, distribute, disseminate or otherwise exploit the Experian Materials.
- 1.3. The following will apply with regard to copyright statements:
  - 1.3.1. Each copy of Goad and Ordnance Survey output made by the Client must bear the written authority: "Experian Goad Digital Plans include mapping data licensed from Ordnance Survey. © Crown copyright and database rights [insert year] OS 100019885", or such other copyright statement notified from time to time to the Client by Experian.
  - 1.3.2. Each copy of Goad and Land & Property Services output made by the Client must bear the written authority: "Experian Goad Digital Plans include mapping data licensed from Land & Property Services © Crown copyright and database right [insert year] VARCA 100552", or such other copyright statement notified from time to time to the Client by Experian.
  - 1.3.3. Each copy of Goad and Ordnance Survey Ireland output made by the Client must bear the written authority: "Experian Goad Digital Plans include mapping data licensed from Ordnance Survey Ireland. © Ordnance Survey Ireland (insert year]. All rights reserved. Licence number EN0087518", or such other copyright statement notified from time to time to the Client by Experian.
  - 1.3.4. Experian will provide the Client with the correct wording in the plot layout provided with the Goad Digital Plans. If the Client designs its own plot layout, the Client must ensure that the same wording is incorporated within those layouts.

- 1.4. The following will apply with regard to use of Experian Materials on the internet:
  - 1.4.1. The Client shall be entitled to place extracts from Goad Digital plans supplied hereunder on the internet for site identification/marketing purposes only. The Client must either be the current legal owner or occupier of the property shown on the extract or a professional advisor currently instructed to act on either the owner or occupier's behalf.
  - 1.4.2. These extracts must be no greater in size than A4 (210mm x 297mm) and must be at the same scale as the original plan (1: 1000). Each extract must show and print either alongside or under the image the applicable copyright statement(s) per Clause 1.3 of these Terms and Conditions, or such other copyright statement notified from time to time to the Client by Experian.
