

## EXPERIAN Pandora Limited Use End-User License

**PLEASE READ THIS SOFTWARE LICENSE AGREEMENT (“LICENSE”) CAREFULLY BEFORE DOWNLOADING EXPERIAN PANDORA LIMITED USE. IF YOU DO NOT AGREE TO ABIDE BY THE TERMS OF THIS AGREEMENT, YOU MAY NOT INSTALL OR RUN EXPERIAN PANDORA LIMITED USE (THE “PRODUCT”) AND MUST DELETE ANY COPIES OF THAT PRODUCT IN YOUR POSSESSION. IF YOU AGREE TO THE TERMS OF THIS LICENSE WITHOUT MODIFICATION, THEN YOU MAY INSTALL AND RUN THE ENCLOSED PRODUCT UNDER THIS LICENSE SUBJECT TO THE FOLLOWING RESTRICTIONS:**

**1. EXPERIAN DATA QUALITY will** provide the Product to the User for a period of 90 days (**the “Term”**) to enable the User to use the Product for its internal business purposes only (“Permitted Use”). The User may apply for a renewal of the licence and Experian Data Quality reserve the right to renew the licence at its own discretion.

### **2. The User agrees:**

2.1 that it will not install the Product on more than one computer and may not run the Product on a network or server accessible by any other computer;

2.2 that it will not without Experian Data Quality’s written consent create a derivative work from all or any part of the Product by any means, extract, copy, sub-licence, transmit, translate, modify, fix bugs or errors, decompile, disassemble or reverse engineer the Product (save to the extent permitted by law) nor disclose any detail of the Product discovered by the User, whether during the Term or otherwise, except to Experian Data Quality and this Clause 2.2 shall survive termination or expiry of this Licence

2.3 not to use the Product as part of a service provided to a third party or as a service bureau and shall not combine the Product with any other software, scripts, code, hardware or tool.

2.3 all intellectual property rights in the Product will remain vested in Experian Data Quality and that no intellectual property rights in the Product transfer to, or are acquired by, the User under this Licence and the User shall therefore not attempt to claim any title to any of Experian Data Quality (or its licensors’) intellectual property rights and further agrees that it will not, at any time, do, or omit to do, anything which is likely to prejudice Experian Data Quality or its licensors’ ownership of such intellectual property rights;

2.4 to observe in good faith the Experian Data Quality standard integration and acceptance test procedures for the Product provided to the User where available and to report to Experian Data Quality Technical Support any problems encountered with the Product or with improvements to the Product;

2.5 to comply with all relevant laws and regulations, including privacy and data protection laws and regulations, in their use of the Product. In particular, the User will act in accordance with the Data Protection legislation, regulations, or codes of practice relevant to their use of the Product;

2.6 Experian Data Quality reserves all rights and discretion to make available to the User any updates, upgrades, content, new versions, maintenance or support to the Product;

2.7 to allow Experian Data Quality at any time during normal business hours to enter the premises of the User for the purposes of verifying compliance with the terms and conditions of this Licence; and

2.8 on termination of this Licence or on or before the end of the Term, as the User may decide, to stop using the Product (**access will be technically disabled after the Term**) or place an order on Experian Data Quality for a full commercial licence for the Product.

### **3. Warranties**

TO THE EXTENT PERMITTED BY LAW, EXPERIAN DATA QUALITY GIVES NO CONDITION, WARRANTY OR REPRESENTATION CONCERNING THE PRODUCT (IN PARTICULAR, THE DATA AND ANY REPORTS GENERATED WITH THE AID OF IT), AND ALL IMPLIED CONDITIONS, WARRANTIES OR REPRESENTATIONS (AS WELL AS LIABILITY FOR NEGLIGENCE) IN RELATION TO THE PRODUCT AND RELATED SERVICES ARE NEGATED AND EXCLUDED. THE USER AGREES THAT TO THE EXTENT PERMITTED BY LAW, EXPERIAN DATA QUALITY IS NOT LIABLE FOR ANY LOSS OR DAMAGE, INCLUDING CONSEQUENTIAL LOSS OR DAMAGE, WHICH IN ANY WAY RESULTS FROM THE USER’S USE OF THE PRODUCT OR IN CONNECTION WITH THE PROVISION OF SERVICES IN RELATION TO THE PRODUCT (INCLUDING INSTALLATION AND ADVISORY SERVICES). THE USER ACKNOWLEDGES THAT THIS IS REASONABLE AS THE USE OF THE PRODUCT DURING THE TERM IS FREE OF CHARGE.

### **4. Termination**

4.1 Experian Data Quality may immediately terminate this Licence by notice in writing to the User, without liability, :

4.1.1 At any time for convenience; or

4.1.2 if the User breaches any term or condition of this document.

4.2 Upon termination or expiry of this Licence, the User shall promptly return or destroy any material or documentation received from Experian Data Quality relating to the Product, including, without limitation, the Software and the Data, and certify that it has complied with this Clause upon request from Experian Data Quality.

**5. General**

5.1 This Licence and all matters arising out of or in connection with it shall be governed by and to be construed in accordance with the laws of England. The English courts shall have exclusive jurisdiction over any claim or matter which may arise out of or in connection with this Licence.

5.2 Nothing in this Licence affects the statutory rights of consumers that cannot be waived excluded or limited by contract.

5.3 Every provision of this Licence is severable from the others and the severance of a provision will not affect the enforceability of any other provision.
